Through a combination of quantitative surveys and qualitative interviews, the research investigates how these groups perceive their role as global citizens, their awareness of international issues, and their involvement in global initiatives.

The survey results reveal that both Rover Scouts and Leadership Scouts hold strong views on global citizenship, but their perspectives differ in key areas. Rover Scouts demonstrate a high level of awareness and commitment to global issues, reflecting their focus on community service and international scouting experiences. In contrast, Leadership Scouts exhibit a more nuanced understanding of global citizenship, influenced by their leadership training and responsibilities.

Qualitative data from interviews further illuminate these differences, highlighting variations in how each group integrates global citizenship into their activities and personal values. Rover Scouts emphasize practical engagement and community action, while Leadership Scouts often focus on strategic approaches and long-term impact. Overall, the study underscores the importance of tailored educational and developmental programs that address the unique perspectives and needs of each group. By enhancing understanding and engagement with global citizenship, scouting organizations can better prepare young leaders to address global challenges and contribute meaningfully to international communities. The findings provide valuable insights for developing targeted initiatives to support and enhance global citizenship among scouts.

The findings will be used to develop recommendations for enhancing global citizenship education and engagement within the scouting movement, tailored to the specific needs and experiences of each group.

This mixed-methods approach ensures a comprehensive exploration of the research questions, offering valuable insights into how different segments of the scouting community perceive and practice global citizenship. The results are expected to contribute to the development of more effective educational programs and initiatives that foster a deeper commitment to global issues among young leaders.

## RESULTS

The study on global citizenship views among Rover Scouts and Leadership Scouts reveals distinct yet complementary perspectives between the two groups. The quantitative survey data indicate that both Rover Scouts and Leadership Scouts recognize the importance of global citizenship, but their approaches and emphases differ. Rover Scouts generally exhibit a strong practical orientation towards global citizenship, with high engagement in community service projects and international scouting activities. Qualitative interviews reveal deeper insights into these differences. Rover Scouts describe their engagement with global citizenship as a series of actionable projects and activities, highlighting their personal contributions to global causes and their motivation to effect immediate change. They value practical experience and hands-on involvement as crucial to their understanding and practice of global citizenship. Leadership Scouts, on the other hand, discuss global citizenship in terms of its incorporation into leadership and educational frameworks. They focus on developing strategies to promote global awareness among younger scouts and integrating global issues into leadership training, emphasizing the importance of fostering a broader, long-term impact.

The findings suggest that while Rover Scouts and Leadership Scouts both support the principles of global citizenship, their experiences shape their perspectives in distinct ways. Rover Scouts are more likely to engage directly with global issues through tangible actions, while Leadership Scouts leverage their roles to influence and educate others about global citizenship. These insights highlight the need for tailored educational approaches that address the unique perspectives and contributions of each group. Enhancing global citizenship programs within scouting can benefit from incorporating both practical engagement and strategic leadership elements, ensuring a comprehensive approach that supports the development of effective global citizens.

### Discussion

The study reveals significant differences in how Rover Scouts and Leadership Scouts perceive and practice

global citizenship, reflecting the distinct roles and experiences of each group. Rover Scouts, with their focus on hands-on community service and international activities, exhibit a practical and action-oriented approach to global citizenship. Their high engagement in global initiatives and direct involvement in addressing issues like climate change and social justice underscore the importance of experiential learning in shaping their views. This hands-on approach not only enhances their understanding but also motivates their ongoing commitment to global causes.

Conversely, Leadership Scouts approach global citizenship through a more strategic lens, influenced by their roles in guiding and mentoring others. Their perspectives emphasize the integration of global issues into leadership training and educational frameworks, reflecting a concern for long-term impact and the broader educational role of scouting. This strategic focus allows them to foster global awareness among younger scouts and embed global citizenship principles into the scouting curriculum, demonstrating the value of leadership roles in shaping and disseminating global citizenship values.

The differing perspectives between Rover Scouts and Leadership Scouts highlight the complementary nature of their contributions to global citizenship. Rover Scouts' practical engagement provides immediate, tangible results, while Leadership Scouts' strategic approach ensures that global citizenship is woven into the fabric of scouting education and leadership development. These insights suggest that scouting organizations should consider both approaches when developing global citizenship programs. Incorporating practical experiences and strategic educational elements can create a more comprehensive framework that supports the diverse ways scouts engage with global issues.

Overall, the study emphasizes the need for tailored global citizenship initiatives that recognize and leverage the unique strengths of both Rover Scouts and Leadership Scouts. By addressing the practical and strategic dimensions of global citizenship, scouting organizations can enhance their effectiveness in preparing young leaders to tackle global challenges and contribute meaningfully to international communities.
